**Summary Annual Report for the  
CONSTRUCTION INDUSTRY LABORERS  
SUPPLEMENTAL MEDICAL AND RETIREE TARGETED (SMART) FUND**

This is the summary annual report for the CONSTRUCTION INDUSTRY LABORERS SUPPLEMENTAL MEDICAL AND RETIREE TARGETED (SMART) FUND, BIN 47-1182916, Plan number 001 for the period January 1, 2016 to December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$122,125. These included benefit payments of \$21,600, administrative expenses of \$100,525, and \$0 in other expenses. A total of 3,117 persons were participants in or beneficiaries of the plan at the end of the plan year, although some may not have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$3,261,387 as of December 31, 2016, compared to \$1,920,652 as of January 1, 2016. During the year the plan experienced an increase or (decrease) in its net assets of \$1,340,735. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income (loss) of \$1,462,860, including employer contributions of \$1,425,377, employee contributions of \$0, gains or (losses) of \$0 from the sale of assets, and net earnings from investments of \$37,483.
